The Draft Sampling and Analysis Plan for the Silver Lake Water Quality Monitoring Project is available for public comment. The Draft SAP describes the proposed scope of the field sampling program, including locations, schedule, and methods to be used. This program involves the sampling of surface water, groundwater and sediment within Silver Lake, its tributaries, and the supporting water bodies (Monponsett ponds, Furnace Pond), evaluation of the resulting data, and development of potential alternatives for consideration for both short- and long-term management of Silver Lake.

The CPCWDC is hosting a public meeting to review the plan with interested stakeholders and provide an opportunity for questions and input.
