A late fee of 50% of the original cost of the license/permit will be charged for any renewal applications not filed and completed by the applicable date of expiration. After expiration date an additional \$1.00 per day will be assessed until license is renewed.	50% after date of expiration and \$1.00 per day thereafter until license is completed and issued. <i>(Amount calculated on date of issue to be paid prior to issuance)</i>
